Paul will address cybersecurity is a phenomenon that keeps everyone involved in the manufacturing and use of medical devices alert. Each and every detail during the manufacturing process of a medical device is subject of quality control and where applicable, also evaluated in the light of (cyber) security. Are the software and data being produced adequately protected against attacks? Philips diagnostic devices are subject of intensive controls. In the medical area we see an increase of all sorts of wearables and sensors, especially the popular once, which collect medical data. These types of devices should be included in the discussion of security as well. In fact, all devices in the continuum of care. Although manufacturers have their procedures but as form the moment a device has been installed, in use, the ecosystem of that device is subject of evaluation. From the use of the device up to the moment data are being shared. Each and every step in that chain should be evaluated regularly. Usually the weakest point is the end user. This presentation will address that chain and will discuss topics that requires continuous attention of all people involved, including the patient.
